3. Confirmation of the minutes of 10th January 2019

These minutes were agreed and signed by the Chairman.

4. Matters arising from those minutes

a. Speed Limit Review and Speed Monitoring

Cllr. M. Gray would forward the speed survey results which he had received.

b. Huntercombe Golf Club

The chair had met with the new course director. The golf club had left timber for firewood for parishioners use. Regular meetings and updates had been promised. The club had agreed to keep the parish council in the loop regarding the outline permission for the 8 houses but had no clear plans to act on this permission at present. They would fully consult SODC forestry and countryside officer over their winter grounds plan.

They had kindly offered to cut the children's playground as well as Fred's Field. The 16th hole near The Crown would have the fairway moved to protect the balls from entering the grounds of the new houses.

c. Quotes for Painting Village Entrance Gates

Cripps had quoted £640 (no VAT). It was agreed that this should go ahead and Chair would organise.

d. Cul de Sac Sign Churchfield

This was currently being processed.

e. Refurbishment of historic bus stop sign

No progress had been made.

f. Grass Verges opposite 22 Churchfield

No parking had taken place after the clerk had written to the owners.

g. Local Plan

4. The Chair stated she had responded on the Local Plan with the comments that the infrastructure must be in place such as schools and doctors to accommodate the extra population.

h. Litter Pick

This had again been successful.

5. Holy Trinity Nuffield

Heating and lighting plans were being finalised along with the flooring. The architects were producing plans. Planning permission would be required for the external works. The Leda application had been submitted.

6. Report from Cllr. Mark Gray

- 1. Street lights were being replaced with LED bulbs which would in the long term be self funding through reduced energy charges.
- 2. OCC has now completed its budget and Council tax will increase by the government allowed maximum of 2.99%.
- 3. £0.5m is available over the next 2 years to spend on Youth Services. This is not to fund existing services but to provide additional services such as extra sessions for existing clubs, and one to one sessions with disaffected children and their families.
